Being young girls we care deeply about these topics, so we decided to analyze this news to understand if there are still defenders of these violence

ANALYSIS

Analyzing the article we found that:

The title is ambiguous because the defense tribunal can not be favorable to aggressive behavior, especially if it is a defenseless person; because according to Article 572 of the Criminal Code, paragraph 1, formally referring to ill-treatment in the family or against children, “anyone mistreating a family person or in any case cohabiting, or a person subjected to his authority or entrusted to him for reasons of education, care, , supervision or custody, or for the exercise of a profession or an art, is punished with imprisonment from two to six years “.

Furthermore, the article was not written in a partial context, but all the points of view were not integrated. In fact, it exposes the point of view of the lawyer and of the court that acquitted him, but not that woman or of his family .. So only the point of view of the man was deliberately expressed because the newspaper wanted to create a news that would talk and discuss on this issue, so as to make the man look innocent and so that the reader would be on his side.

The article, therefore, puts the woman in a bad light, as it clearly suggests that the violence suffered by her are not entirely real given the analyzes carried out on the medical reports of which diagnoses do not emerge connections between the man and the woman, therefore, the woman is accused of having lied about the origin of the wounds and the quarrels.

CONCLUSION

The most important result of the research is the verification of the falsity of the news concerning the discussion of current topics; moreover, the lawyer Coluccio suffered professional damage because he was defamed for his position and for defending a man who was in favor of abuse.

The news is a cause of confusion and concern especially by women already victims of aggression and sowing terror even in women who are not victims of abuse because it is in favor of violence.

Another interesting aspect is the response of Francesca Puglisi, the chairwoman of the commission against femicide, which alarms on the gravity of the situation, hoping for a review of the trial. This quote supports falsehood to make the news appear true and discussed.

So, we have come to the conclusion that the news is partially fake, because the violence is ascertained, but they have not been judged punishable according to the suggested categorization.
